Attached is a Notice of Intent to Develop a Groundwater Sustainability Plan (GSP) for the Merced Subbasin. This is being provided to you on behalf of the Merced Subbasin Groundwater Sustainability Agencies (GSAs) in accordance with California Water Code Section 10727.8. It states that if the geographic area covered by the GSP includes a public water system regulated by the Public Utilities Commission (PUC), the groundwater sustainability agencies shall provide notification of the initiation of the GSP to the PUC. The California American Water – Meadowbrook system is located within the geographic boundaries of the Merced Subbasin GSP.

Subject: Notification of Intent to Develop a Groundwater Sustainability Plan for Merced Subbasin

Dear Mr. Joseph,

In accordance with California Water Code Section 10727.8 and California Code of Regulations, Title 23, Section 353.6, the Merced Irrigation-Urban Groundwater Sustainability Agency (MIUGSA), the Merced Subbasin Groundwater Sustainability Agency (MSGSA) and Turner Island Water District Groundwater Sustainability Agency - 1 (TIWDGSA) hereby give notice to the California Department of Water Resources (DWR) that they will initiate development of a Groundwater Sustainability Plan (GSP) for the Merced Groundwater Subbasin.

The Merced Subbasin is one of 21 basins in the State of California identified by DWR as critically overdrafted and one of 48 basins considered high priority. The Merced Groundwater Subbasin has both significant sustainability challenges and a long history of water agencies and stakeholders working collaboratively to meet these challenges. The Merced Subbasin GSAs look forward to developing a GSP collaboratively through robust stakeholder and public outreach and in coordination with neighboring basin GSAs.

The public may participate in the planning process multiple ways. The GSAs each hold regular meetings open to the public and welcome public participation and input. In addition, the GSAs will be convening a Stakeholder Coordinating Committee for the GSP process. Public workshops specific to the development of the GSP will be conducted to encourage public participation and to provide educational outreach. Workshops will be noticed publicly via website and to the list of interested parties maintained pursuant to Water Code Section 10723.2. Additional information on SGMA and the GSP process for the Merced Subbasin will be available at the website www.Mercedsgma.org.
