**Background**

The July 2022 Revision of the Merced Subbasin GSP includes updates to the November 2019 Groundwater Sustainability Plan (GSP) in response to the Statement of Findings issued by the California Department of Water Resources (DWR) on January 28, 2022. The GSP has been updated in several key places to address DWR's recommendations. A redlined version of the GSP that highlights the edits can also be found on [MercedSGMA.org](http://MercedSGMA.org). The revision was developed openly and transparently with substantial input from the public, including at public meetings held on January 31, February 7, March 21, April 25, June 1, and June 27. The revised GSP is now ready to be considered for adoption. Once adopted, the revised GSP will guide groundwater management in the Merced Subbasin.
